

TNEBEA wish to bring the notice of CMD on the caption subject. The Association requested the Board on many occasions to recruit the AEs in the same calendar year if the AEs are appointed through internal selection so as there shall not be any legal tussle in seniority among those AEs as there is a procedure in the board to fix the inter se seniority as per Service regulations between directly recruited Assistant Engineers and internally recruited Assistant Engineers in the ratio of 1:1 in the particular calendar year.

In the reference (1) cited, Assistant Engineers have been appointed internally taken into account the prospective recruitment of Asst Engineers under direct recruitment through TNPSC.

But as on date, it is learnt that the list of successful candidates who have appeared in the examination conducted by TNPSC is to be received by the Chief Engineer / Personal for issuing necessary posting orders. In spite of the repeated request from TNEBEA during various occasions regarding release of the successful candidates for the post of Assistant Engineers through TNPSC for the year 2025, the list is not yet released.

In this context, the Association wish state that if the list is not received within this calendar year, i.e., before 31.12.2025, it is the duty of the organisation to ensure that the directly recruited Assistant Engineers shall not get affected in their legitimated seniority.

Hence, the Association earnestly requested the CMD to arrange to issue necessary orders to maintain the seniority among both the Directly recruited and internally recruited AEs in the year 2025 itself so as to ensure justice towards the seniority of the directly recruit recruited Assistant Engineers and oblige.
