As the motto of TNEBEA is to enhance the operational efficiency of the organization with mutual development of the Organisation as well its employees, the following points are put forth for consideration and necessary action:

1. To expedite the recruitment process for the 400 Assistant Engineer posts pending with the Tamil Nadu Public Service Commission (TNPSC) and issue necessary posting without affecting their seniority in the year 2025.
2. To prepare supplementary panel for the post of 9 Nos CE/Electrical and CE/Mechanical and Civil for the arising vacancy in the month of January 2026.
3. To include all the 2012 batch of Assistant Engineers in the Assistant Executive Engineer (AEE) Electrical and Mechanical promotion panels and arrange to conduct the DPC meeting at the earliest.
4. To expedite early preparation panel and issue of posting on promotions to all the cadres AEE, EE, SE & CE (Electrical, Mechanical and Civil) considering the ensuing Tamil Nadu assembly election.
5. AE to AEE /CIVIL Suitability called vide Letter No 042038/G.2/G.2(1)/2025-4, dated 11.09.2025, DPC may be conducted at the earliest and promotion orders may be issued.
6. In line with Government of Tamil Nadu's formation of new Mayaladuthurai district, a new circle may be formed bifurcating Nagapattinam and Thiruvarur circles.
