In the Board's Proceedings first cited, detailed guidelines were issued for deduction of Annual Union Subscription and donation from the salary of the willing employees. In the standard terms and conditions annexed to the Board's proceedings, it has been ordered that subscription shall be deducted from the pay bill for May payable in June and donation shall be deducted from the pay bill for November payable in December every year.

2. In the reference second cited, orders were issued for the deduction of Annual subscription and Donation for a sum of Rs.600/- and Rs.600/- respectively from the salary of the willing members of Tamil Nadu Electricity Board Engineers' Association who made specific written authorization.

3. Now, the General Secretary of Tamil Nadu Electricity Board Engineers' Association has made a specific request for enhancement of Annual subscription a sum of Rs.1000/- and Annual Donation a sum of Rs.1000/- from the salary of the willing employees of the above said union, who give specific written authorization.

4. The request has been examined and accepted. Accordingly, it is hereby ordered that a sum of Rs.1000/- towards Annual subscription and Rs.1000/- towards Donation be deducted from the willing members of Tamil Nadu Electricity Board Engineers' Association, who made specific written authorization. **The enhanced Subscription shall be deducted as per the orders issued in the reference fourth cited for this year alone** and enhanced Donation shall be deducted from the pay bill for the month of November 2020 payable in December 2020 onwards. Subsequent Subscription/Donation may be deducted as per reference first cited.

5. The Annual subscription and donation shall be made in the Account Head : 44 - 453 - Tamil Nadu Electricity Board Engineers' Association.
