In the reference 2nd cited, instructions were issued to Superintending Engineer/EDCs to issue notices to the Captive Generators separately for the Financial Year 2014-15 to 2018-19 to submit the required documents as directed in R.A.No.07 of 2019 by Hon'ble TNERC dated 28.01.2020 in order to verify the captive status. A model notice format was also sent along with the letter.

2.0) Subsequently due to the Lock down announced by the Government of Tamil Nadu due to COVID-19 Pandemic, Hon'ble TNERC permitted the submission of documents by the Generators within 4 weeks from the date of lifting of lockdown and also directed to submit the monthly progress on issuance of notices.

3.0) It is seen from the various press release issued by the Govt of Tamil Nadu that almost all the industries except certain industries have been permitted to work with 100%/50%/33% as the case may be Many of the industries have commenced their operations.

4.0) It is seen from the table that the issuance of notices is yet to be completed fully even after relaxation announced by the Government of Tamil Nadu. The above non issuance results in delay in completion of the verification process which has to be completed in a time bound manner as stipulated in the order RA.No.07 of 2020 dated 28.01.2020.

5.0) In the view of the above, Superintending Engineer/EDCs are hereby instructed to arrange to complete the issuance of notices within a week's time failing which responsibility will be fixed on the officials concerned.
