The Chairman has also accorded approval to the Superintending Engineer/Operation/South Chennai to float & award works contract for day to day operation & maintenance works of the new Pulianthope 400/230 KV GIS Substation for tendered value of three Crores, anticipating the revised PWD Schedule of Labour rates for the year 2021-22.
