#### **PROCEEDINGS:-**

The Erstwhile TNEB was formed on 01.07.1957 to do business of generation, transmission and distribution of electricity within the State. At the time of formation of Board, a Secretariat and the Office of the Chief Engineer and other sub-ordinate offices were formed. The Headquarters was re-organized with effect from 01.08.1979 and the powers were decentralized towards effective administration and consumer satisfaction by forming the following Branches:-

- > Secretariat Branch
- Administrative Branch
- Accounts Branch
- Audit Branch
- > Technical Branch
- 2. The establishment related matters of the Class-I Officers and the policy matters of the organization, regulation, Wage Revision, Legal, Vigilance etc. are being handled in the Office of the Secretariat Branch. The establishment related matters of Class-II, III and IV Services, viz. recruitment, Labour issues etc. are being handled in the Office of the Administrative Branch.
- 3. The officials working in the above offices are having separate seniority within their Branches. The establishment related works of the Class-II, III and IV Services in the region offices and circle offices are dealt by the officials working in the region offices and in the circle offices. They are governed by separate state seniority.

4. The hierarchy structure of the officials working in the Secretariat Branch, Administrative Branch and Region/Circle offices are as follows:-

In order to stream line and to ensure better and efficient human resource management among all the staff/officials and to gain experience in field and Headquarters activities, it has been decided to interchange the officials/staff among the above offices. The Chairman-cum-Managing Director/ TANGEDCO has approved the above proposal.

Accordingly, it is hereby ordered that the official/staff working in the Secretariat Branch, Administrative Branch and region/circle offices shall be interchanged vice versa to gain experience and to improve the work nature and for better service to the staff. Due to the above interchange, the lien to be continued in their concerned Branch/Office and the level of pay are protected without any change in the seniority. The establishment related matters will rest with the concerned Branch/Office where their lien is ensured.
- 8. Consequent to the orders issued above, no additional post will be created/abolished.

- 9. This order will take immediate effect.
- 10. The receipt of this proceedings shall be acknowledged.
