ORDER:

The Hon'ble Chief Minister of Tamil Nadu has made announcement three phase power supply is being extended to agricultural services for 24 hours in Tamil Nadu.

2. The Hon'ble Chief Minister has made an announcement as follows:-

"இதய தெய்வம் அம்மாவின் அரசு, விவசாயிகள் பயன்படுத்தும் பம்பு செட்டுக்கு மும்முனை மின்சாரம் இனி 24 மணி நேரமும் வழங்கப்படும் என்ற மகிழ்ச்சியான செய்தியை இந்த பொதுக்கூட்டத்தின் வாயிலாக தெரிவித்துக் கொள்கிறேன்."

- 3. The Principal Secretary /Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited has proposed on the above announcement and stated that at present, the power supply is given to Agriculture consumers in Delta for 12 hours and Non Delta areas for 9 hours. The cost to Tamil Nadu Generation and Distribution Corporation Limited is compensated by Government of Tamil Nadu as agricultural tariff subsidy. As the duration of power supply is to be increased, the consumption is likely to go up and the quantum of subsidy also needs to be increased proportionately.
- 4. The Government after careful examination have decided to accept the proposal of the Principal Secretary /Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited referred to in para 3. Accordingly, the Government direct Tamil Nadu Generation and Distribution Corporation Limited to extend three phase supply for 24 Hrs for agriculture services.

- The additional subsidy, to be compensated to TANGEDCO will be determined based on the tariff petition filed before the Tamil Nadu Electricity Regulatory Commission as part of agricultural subsidy.
- 6. The above extension of 3 phase 24 hours power supply to agriculture feeders will be implemented w.e.f. 1.4.2021.
