PROCEEDINGS:

In the reference first read above, orders have been issued revising the fee structure of the Board's Standing Counsels as in Government. The Standing Counsels of TANGEDCO have requested for revision of retainer fees and other Legal charges, since the Government of Tamil Nadu has revised the same vide in the G.O. second read above.

2) In compliance with the orders of the CMD/TANGEDCO, the fees and other Legal charges payable to the Standing Counsels of TANGEDCO, TANTRANSCO be revised and fixed as detailed in the Annexure.

3) The Standing Counsels while assisting to the Advocate General/ Additional Advocate General/ Senior Counsel for the cases in High Court , CERC, 1/3rd of the Legal fees shall be paid, should not exceeding his/her appearances fees in their respective court.

4) The Advocate on Record while assisting the Advocate General/ Additional Advocate General/Senior Counsel in the cases before in Honourable Supreme Court/ New Delhi/ APTEL, 1/3rd of the fees shall be paid a ceiling of Rs.30,000/- or 1/3rd fee of the Senior Counsel whichever is lower.

5) The expenditure regarding the Retainer fee and other Legal fees shall be debited to the head of **Account Code – "76.121"**.

6) The above orders shall take effect from 1st January 2021


