A High Level committee has been formed based on B.P. issued vide ref cited above and the first meeting was held on 30.04.2021.

The High Level Committee has requested the following details for the period from 2017-18 to 2020-21 in respect of North Chennai TPS I & II and Tuticorin TPS:

1. Month wise Opening Stock, Coal receipt, consumption and closing stock.
2. Month wise generation.
3. Month wise Specific Coal Consumption and Station Heat rate.
4. Records of Coal Stock verification done by Head quarters team.

5. Records of periodical verification of Coal stock done by Thermal Stations.
6. Stock account maintained by Store Officers.
7. Details of periodical checking of weighing equipments done.
8. Coal sent to MTPS. (for NCTPS only).

The CE/MTPS-I & II are requested to furnish the details in respect of Sl. No 4, 5 & 7.

The above details may be furnished in three sets and soft copy may also be furnished.

As the Committee has to submit the report within 15 days, the above particulars may be furnished immediately on or before 03.05.2021.

PROCEEDINGS:

Approval has been accorded to form a High level committee to inspect and review the coal stacking procedures, accounting procedures, available stock as per Stores Book and actual coal stock, reason for variations in stock if any, etc in the Five Thermal Power Stations of TANGEDCO, to ensure a proper and uniform procedures are adopted.

The High level committee consists of

1. The Director/Generation
2. The Chief Financial Controller/Revenue
3. The Chief Engineer/ Non Conventional Energy Sources.

The Superintending Engineer/Coal Handling/ O/o.Chief Engineer/Mech/Coal, Chennai-2 has been nominated as convener of the committee.

It is brought to knowledge that actual coal stock in NCTPS.I and TTPS is less than what is reported, and it involves high quantity of coal. It is being such an important matter, there is need to enquire about the reasons for these shortages. Thus the committee has to enquire about the reasons and to fix the responsibility with the officers for these lacunae.

The committee members may obtain the necessary inputs from the Chief Engineers, Superintending Engineers and Stores Officers of the Thermal Power Stations and submit the report within 15 days of time.


