PROCEEDINGS:-

Under regulation 92 of the Tamil Nadu Electricity Board Service Regulations read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, Tmtty K.N.Santhini, Superintending Engineer/ General Construction Circle/ Coimbatore, is promoted and appointed as Chief Engineer/Electrical, in Division-I, Class-I of Tamil Nadu Generation and Distribution Corporation Limited service with effect from the date of assumption of charge.
