All the Directors of TANGEDCO/TANTRANSCO, Legal Adviser, Chief Engineers, Chief Financial Controllers, Chief Internal Audit Officer and all other officers of TANGEDCO/TANTRANSCO are instructed to be present during the Legislative Assembly Session in their office from 09.30 A.M. to till the Chairman-Cum-Managing Director/TANGEDCO leaves the office, whichever is later, till the Assembly Session is over.

3. All the staff of the TANGEDCO/TANTRANSCO are instructed to be present during Assembly Session in the office by 09.30 A.M. on all working days from 21.06.2021 till the Assembly Session is over.

4. During the period of Assembly Session, undertaking of tours may be avoided. In exceptional circumstances, the officers concerned should obtain prior approval of the Chairman-cum-Managing Director and Directors concerned.

5. All the Officers of the TANGEDCO and TANTRANSCO are instructed to communicate this memorandum to all the staff working under their control.

6. Any violation of this instructions will be viewed very seriously.
