

8. Sanction of PG increment who have completed with prior approval, consider the Government G.O dated 30.3.2021.
9. Issues in taking of LTCT readings by section officers, it is suggested for PMC for LTCT consumers
10. Line patrolling & maintenance report in three days, it is requested for instructions for maintaining supply and attend breakdowns only until covid surge.
11. Additional Charge Allowance – Wrong audit interpretations and recoveries still made in thermal stations. (The wrong interpretation of filed post with the new keyword "PLANT POST" by JMD/TANGEDCO may be revisited and dropped and favour the genuine additional charge allowance).
12. Issues of Hydro Engineers – relief with special priority in filling up the vacancies particularly in the hill locations.
