Sub: TANGEDCO – Electricity –Effecting of agriculture service connection under Fast Track TATKAL SFS scheme during 2021-22– working instructions issued-Reg.



- 1.0 It is informed that, necessary agriculture service connection target has been fixed and instructions issued for 2021-22 in the reference cited above where in it has been instructed to effect agricultural service connections under Fast Track (Tatkal) SFS scheme, as and when willingness is received from the applicant, the same shall be considered and service connection effected as per the procedure applicable for Fast Track (Tatkal) SFSs scheme.
- 2.0 In this regard, the following working instructions are issued in respect of effecting agricultural service connections under Fast Track (Tatkal) SFS scheme:
 - a) Fast Track (Tatkal) Self financing scheme is an optional and purely on the willingness of the registered applicants. It does not affect the regular waiting seniority of the applicants.
 - b) All the agriculture applications registered under LT tariff IV for the load up to 15 HP may be considered for this scheme and collect the scheme cost as detailed below:

Load upto 5 HP	-	Rs.2.50 Lakhs
Above 5 to 7.5 HP	-	Rs.2.75 Lakhs
Above 7.5 to 10 HP	-	Rs.3.00 Lakhs
Above 10 HP to 15 HP	-	Rs.4.00 Lakhs

- c) From 14.9.2021 onwards all the registered agriculture applicants (existing and new) who are willing to opt under the above scheme can make the one time payment.
- d) Name transfer and SF change if any should be completed before acceptance under this scheme. Reduction of load is not permitted. After verifying the revenue documents as per Form-2 of TNERC Amendments to the TamilNadu Electricity Distribution code, NOC (if applicable), the willingness application and Demand Draft may be accepted.
- e) Applications are to be processed only through online application tracking in LT billing system. Chief Engineer/IT has to provide necessary facility to collect charges and view facility to monitor the progress on daily basis as done in the previous TATKAL schemes..
- f) The preparation of estimate, execution of works, motor-pump set with capacitor readiness and effecting of power supply are to be carried out as per the procedure explained in the TNERC Distribution code in force.
- g) Separate Section priority should be maintained for this Fast track (Tatkal) Self financing Scheme 2021-22 and to take up the work for the paid cases immediately and separately and categorise the works on mere, minor, major category as per Section priority.
- h) All pending ready parties in other schemes are also to be completed simultaneously.
- i) The Regional Chief Engineers/Distribution shall implement and monitor the Fast track (Tatkal) Self financing scheme 2021-22 and send the progress report to Chief Engineer/Planning & RC every week.

- j) The scheme amount shall be collected under the Account Code No.:55.109.
- k) The Scheme shall be in operation till further instruction from this office.
