

For any new/emergency works (supply not included) and which are not available in the cost data, Chief Engineers /Thermal stations may award the works contract following latest tender procedures being communicated then and there from HQs. The Chief Engineers of Thermal Stations should ensure essentiality of the work and reasonableness of the rates, before issuing works contract.

A monthly report on the details of new work executed if any, along with a copy of the acceptance order and sanctioned estimates, Division wise shall be furnished to MTS office on or before 5th of successive month for updation. If new works are not carried out in a month, a NIL report may be given Division wise.

However, certain additional works are being furnished from few Thermal Stations to CE/MTS Office, as and when arises for inclusion in the revised Cost data. It is learnt that some additional works details had also been directly communicated to IT Wing for inclusion in IMS Portal and not routed through CE/MTS. Hence, upon receipt of final consolidated details for additional/new works from the Thermal Stations, for the period from April 2019 onwards, the same will be scrutinized and Supplementary Cost data for additional/new works will be issued later.

Cost data for labour charges, for those Works common for 210 & 600MW and those Works exclusively for 600 MW, for the preparation of estimates and awarding of Works contract in all thermal stations of TANGEDCO (210 MW & 600 MW) for the Financial year 2020-2021 were issued vide ref (1) & (2) cited, respectively and is in existence till date.

At present, PWD, Govt. of Tamil Nadu has approved and issued the Standard Schedule of rates for the year 2021-2022 (Basic rates excluding GST & Other taxes) to be adopted from 13.09.2021 vide ref(3) cited above.

Accordingly, the rates have been revised and updated in the existing Cost data for labour charges (Works involving labour only) for those works Common for 210 & 600MW and those Works exclusively for 600 MW. These rates shall be adopted henceforth, for estimation purposes only in 210 MW and 600 MW Thermal Stations, until issue of further orders.

Further, the Chief Engineers of Thermal Stations are hereby reiterated that the labour charges communicated in the Cost Data are applicable for works involving labour only. Labour cost data is not applicable for proprietary/ Non Proprietary nature of works contract wherein supply and erection are combined. When Supply and erection works are combined together, routine procedures based on estimates/budgetary offers following regular tender procedures, are to be done as in the case of any works contract.
