PROCEEDINGS:

In the Proceedings first read above, orders have been issued sanctioning Dearness Allowance at the rate of 304% with effect from 01.07.2019 to the Contributory Provident Fund/Non-pensionable establishment beneficiaries of TANGEDCO who are in receipt of Exgratia payment of Rs.645/- per month plus Dearness Exgratia from 04.06.2013. The Government of Tamil Nadu, in the Government Order second read above, have issued orders sanctioning Dearness Allowance to the Exgratia beneficiaries with effect from 01.01.2022. After careful consideration of the orders of the Government, it has been decided to adopt the same.

2. Accordingly, it is hereby ordered that the Dearness Allowance to the Exgratia beneficiaries of TANGEDCO, be enhanced with effect from 01.01.2022 at the rate mentioned below:-

retired prior to 01.07.1986 are entitled for the Dearness Allowance at the rate ordered in para-2 above with effect from 01.01.2022. The payment shall be made immediately.
