- 2. In the Board's Proceedings sixth cited, among others the scheme of sanction of advance increment to the Board's Engineers P.G/Ph.D in Engineering has been cancelled/dispensed. Further, if the Board's Engineers who have been sanctioned advance increment for having acquired P.G/Ph.D in Engineering through Deemed Universities without approval of the Competent Authority (Chairman cum Managing Director) and also studied through distance mode before 18.08.2012, the recognition of the Deemed Universities should be verified by the Secretariat Branch.

In the reference eighth cited, instructions have been issued to the Chief Engineers/Superintending Engineers to send all pending proposals seeking clarification/ratification/regularization to the Secretary/TANGEDCO for sanction of incentive increment by the Competent Authority (Chairman cum Managing Director) after due verification with University Grants Commission (UGC)/All India Council for Technical Education (AICTE) on case to case basis.
