### **PROCEEDINGS:-**

In the Memo. read above, among other things, instructions have been issued for parking arrangements/traffic management to the two wheelers and four wheelers of officers/employees/visitors in the TNEB Complex.

2. Of late, it is noticed that vehicles are parked haphazardly within the campus of TANGEDCO, which creates traffic jam inside the Headquarters complex. To improve the traffic management within the campus of TANGEDCO, it has to be regularized by providing the vehicle pass and to earmark the vehicles to be parked in the respective area only.

3. In order to improve the parking arrangements/traffic management in TANGEDCO/TANTRANSCO/Headquarters Complex the following parking facilities for the vehicles shall be provided inside and outside the campus :-

#### **Two wheelers parking**

1. Two wheeler shed/stand
2. Between Data Centre and Garden
3. TANTRANSCO Building Basement
4. Between Union Office and LD & GO
5. Near union office (for union people)
6. Behind Canteen (western side)

#### **Car parking**

7.	Visitors parking	a. TANTRANSCO (Southern side) VIPs visitors parking b. Gate 1 to Gate 2 (Outside the Campus - Southern side)
8.	Private Van parking	Gate 2 to Cannimera Hotel (Southern side)

4. All Officers of TANGEDCO/TANTRANSCO are requested to circulate this order to all the staff working under their control for strict adherence.

5. All Officers/Staff/Employees are requested to extend their co-operation for implementing the above mentioned arrangements and to get a pass from the Office of the Chief Engineer/Materials Management/Chennai for parking their vehicles.
