PROCEEDINGS:

Based on the orders issued by the Government in G.O.Ms.No.222, Finance (Pension) Department, dated 30.06.2018, orders were issued implementing the New Health Insurance Scheme, 2018 to provide cashless treatment to the Pensioners (including spouse)/Family Pensioners/Exgratia beneficiaries through M/s.United India Insurance Company Limited (M/s.UIICL) with effect from 01.11.2018 for a period of four years in the proceedings first read above.

2. It has been brought to the notice that the Pensioners of TANGEDCO have been facing several hardships in getting the reimbursement of the medical expenses incurred by them in non-network Hospitals, due to the delay in settlement of claims made by them to the Grievance Redressal Officers, i.e. District Level Empowered Committee and State Level Empowered Committee. To sort out the issues, the Secretary/TANGEDCO has convened a meeting with the representatives of M/s.UIICL on 23.03.2022 and it has been decided to constitute a Committee consisting of the representatives from the Directorate of Medical and Rural Health Services/Chennai, TANGEDCO & M/s.UIICL, after obtaining concurrence from the Directorate of Medical and Rural Health Services/Chennai.

3. In the letter second read above, the Director/Medical and Rural Health Services/Chennai has been requested to give the concurrence for constitution of the Committee and to nominate the members from his Directorate. In his letter third read above, the Director/Medical and Rural Health Services/Chennai has nominated Dr.Viswanathan, M.S, Joint Director (Act) and D.P.Senthilkumar, SAS, as Nodal Officers (Grievance Redressal Officers) to examine the claims received from the Pensioners/Family Pensioners of TANGEDCO and to make recommendations to the Empowered Committees for reimbursement under New Health Insurance Scheme, 2018. He has also given concurrence for constituting a Committee to settle the claims
