TANGEDCO accorded necessary sanction for creation of 156 posts in all disciplines for establishing 1x800MW Power Plant at NCTPP-III vide Proceedings 1st cited. It was clearly ordered therein under Para 6 of the above B.P. as below:

"The incumbents of the posts ordered in para.3 above will be eligible to draw the usual pay, Grade Pay, Dearness Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable."

- City Compensatory Allowance is eligible to all employees of Government of Tamil Nadu and Government Corporations working under Chennai Corporation limit. TANGEDCO is one of the Government Owned Corporations and NCTPP-III site lies in the limit of Greater Chennai Corporation. All engineers and employees working in the above project are therefore eligible to draw CCA as permissible under the Proceedings 1st cited.
- 3. While so, the Audit team has raised objection to payment of CCA and ordered to recover the amount already paid. All employees who are still working there and who have moved to other places on transfer after working there remain aggrieved, despite the arduous nature of job there. Normally TANGEDCO builds residential quarters for accommodating the engineers and employees posted to on-going projects to keep up the tempo of the project. Butconstruction of residential quarters is conveniently avoided in respect of NCTPP-III Project. Hence everyone posted there must necessarily commute from their residential homes placed at various places of Chennai City through city trains/ buses. Not even a single facility is available at the project site. There is yet another fact that all of them are subjected to a high degree of pollution for which no compensation is made available. There is only inconvenience in every aspect. In view of the aforesaid reasons, the observation of the audit team is quite unjust and unfair when the discomfort faced by the engineers and employees is duly counted and recognized.
- The engineers and employees serving at NCTPP-III are eligible to draw both Project Allowance since they are engaged in the erection of project and CCA since the project site lies within Greater Chennai Corporation limit. The logic that they are eligible for only one allowance does not appear to be rational.
- The Chief Engineer/ NCTPP-III has recommended payment of CCA listing out many genuine reasons in his letter 2nd cited and requested to drop the above audit observation.
- This Association has been representing to drop the above audit observation for long time vide our letter dated 04.07.2022. The CMD has been kind enough to appreciate the rationale behind our representation and was pleased to pass necessary orders to stop recovery as suggested by the audit team. There is now a threat that recovery is likely to be
