The Director (Generation)/TANGEDCO, Chennai has proposed for re-deployment of the vacant post of Superintending Engineer/Electrical/ Basin Bridge Gas Turbine Power Station as Superintending Engineer/Electrical/ Commissioning/Udangudi Supercritical Thermal Power Project.

2. The above proposal has been examined in detail and it has been decided to accept the same. Accordingly, it is hereby ordered that the post of Superintending Engineer/Electrical/Basin Bridge Gas Turbine Power Station last continued in the Memorandum first read above be redeployed as Superintending Engineer/Electrical/Commissioning/Udangudi Supercritical Thermal Power Project under the control of the Chief Engineer/Civil/Udangudi Supercritical Thermal Power Project.

It is also hereby ordered that consequent on the re-deployment of the post of Superintending Engineer/Electrical/Basin Bridge Gas Turbine Power Station as Superintending Engineer/Electrical/Commissioning/Udangudi Supercritical Thermal Power Project, the administration and establishment works hitherto looked after by the Superintending Engineer/Electrical/Basin Bridge Gas Turbine Power Station be attached to the Executive Engineer/Electrical/Maintenance/Basin Bridge Gas Turbine Power Station.

4. The incumbents of the posts ordered in paras-2 & 3 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force.
