PROCEEDINGS:-

In the proceedings first read above, the panel for the post of Chief Engineer (Electrical) consisting of 39 candidates for the year 2022-2023 has been issued.

2. In the said panel the name of Thiru P.Chandrasekaran, Superintending Engineer, Chennai EDC (North), has not been included in the said panel, since disciplinary proceedings was pending against him. Subsequently, the disciplinary proceedings against him has been dropped. Hence, the name Thiru P.Chandrasekaran, Superintending Engineer, Chennai EDC (North) has been included in the said panel as SI.No.20-A, in the panel for the post of Chief Engineer (Electrical) for the year 2022-2023 vide the proceedings second read above.

3. Consequent on the above, under Regulation 92 of the Tamil Nadu Electricity Board Service Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme, 2010, Thiru P.Chandrasekaran, Superintending Engineer, Chennai EDC (North) is deemed to have been promoted and appointed as Chief Engineer (Electrical) in Division-I, Class-I of the Tamil Nadu Generation and Distribution Corporation Limited service. Accordingly, the following posting orders is issued with effect:-

- i. *Thiru P.Chandrasekaran, Superintending Engineer, Chennai EDC. (North), on his promotion, he is appointed and posted as Chief Engineer, (Distribution) Kanchipuram Region vice Thiru P.Kalimuthu, Chief Engineer relieved from duty.*

4. Thiru P.Chandrasekaran, Superintending Engineer, (Electrical) is eligible for fixation of pay notionally in the post of Chief Engineer with effect from 30.06.2022 on par with his junior Tmt.G.Manimekalai, Chief Engineer (Electrical), who has joined in the post of Chief Engineer (Electrical) on 30.06.2022, as per note-2 under regulation 37 of Tamil Nadu Electricity Board Regulations, read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, as he had not actually acted as Chief Engineer on the above said date.

5. The Chief Engineer (Distribution), Chennai Region (North) is directed to relieve the above officer immediately by making local arrangements without waiting for substitute and instruct him to join at the new post immediately. Otherwise necessary Disciplinary action will be taken against the concerned Official. A report should be sent to the Secretary, Tamil Nadu Generation and Distribution Corporation Limited regarding the date of relieving and date of joining of the officer. This will be apart from the Certificate of Transfer of Charge. A scanned copy of Certificate of Transfer of Charge should be sent via e-mail to soa1sec@tnebnnet.org.

6. An option form for fixation of pay in the promoted post is enclosed herewith. The Officer is requested to return the option form duly filled in, within one month from the date of assumption of charge. If the option form is not received within the said period of one month, their pay in the higher post will be fixed as specified in para-3 of Board's Memo.No. 75406/P1/90-1, dated 19.3.1991
