Chief Engineers/ Electrical as listed below:

2. The post of CE/TTPS is held by a
SE/Mechanical under Full Additional Charge (FAC)
for a long time. The CMD has been kind to
consider our plight and posted TWO regular CEs/
Mechanical terminating the FAC at two Thermal
Power Stations at CE/NCTPS-II and CE/MTPS-I. It
is requested to fill up the post of CE/TTPS with a
regular incumbent from the fresh promotion panel
to be drawn up.

3. There are only 5 sanctioned posts for the
cadre of Chief Engineers/ Mechanical. There are
three incumbents in the posts of (a) CE/Coal, (b)
CE/Mines and (c) CE/M/Thermal Stations at Head
Quarters Office. There is also one more regular

incumbent in the post of CE/ETPS. While so, only one incumbent needs to be considered for promotion as Chief Engineer/ Mechanical. Yet, two incumbents have been considered for promotion and posted as CE/M/NCTPS-II and CE/M/MTPS-I. The Association is constrained to point out that that this violates the solemn convention of having only 2 CEs/ Mechanical against 6 CEs posts in respect of Thermal Power Stations. It is requested that this violation requires to be rectified soon.

4. There is therefore an urgent need for drawl and approval of a fresh promotion panel for the post of Chief Engineers/ Electrical. It is pertinent to observe herein that the crucial date for the post of Chief Engineer/ Electrical is 1st March 2023.

5. The Association, therefore, requests that the respected CMD be pleased to kindly consider necessary urgent measures for drawl and approval of a fresh promotion panel for the post of Chief Engineers/ Electrical early, enabling to fill up the existing and arising vacancies in the future without any delay.
