Kallakurichi EDC had been bifurcated  
from Villupuram EDC in the year 2012 under the  
Proceedings 1<sup>st</sup> cited. This Circle consists of 26  
Nos Sub-Stations with Control Rooms &Quarters,  
4 Nos of Division Offices, 15 Nos of Sub-division  
Offices and 59 Section Offices. All the Division  
offices function in TANGEDCO/TANTRANSCO's own  
buildings.Of course, this Circle has now been  
reallocated to the newly formed Tiruvannamalai  
Region along with Tiruvannamalai EDC and  
Dharmapuri EDC from Villupuram Region.

2. There has been no sanctioned post of Assistant Executive Engineer/Civil since the formation of this Circle. The Chief Engineer/Villupuram submitted a proposal for consideration of sanction of new post of AEE/Civil/Kallakurichi EDC during 2018. It was then suggested to consider abolition of any equivalent post in the Region to offset the expenditure by the CE/Personnel vide letter 2<sup>nd</sup> cited.

3. Now, there is an imperative need for an exclusive Assistant Executive Engineer/Civil to monitor and execute the various civil activities of the Circle as detailed below:

a. The land acquisitions activities: To co-ordinate with GCC, to identify suitable land, to negotiate with the landowners and to liaison with various government agencies for establishing new Sub-Stations. It is pertinent to note herein that 9 Nos of 110/33 kV and 110/22 kV Sub-stations have been proposed under T&D programme under 13<sup>th</sup> & 14<sup>th</sup> Master Plan and RDS Scheme) under Kallakurichi EDC.

b. To evolve estimates for the construction of new building for the Central Office to house Superintending Engineer Office, MRT & Special Maintenance Indoor Repair Bay, Construction of own buildings for the Section Offices at Nainarpalayam, Kachirapalayam, Vadaponparappi and Rishivanthiyam.

c. To process ROR proposals for about 34 Nos Section Offices and SE's Office which are functioning in rental buildings on time.

d. To carry out routine civil maintenance works periodically.

4. It is understood that one post of Assistant Executive Engineer/Civil has been proposed for redeployment from the SE/Civil/DRIP, Madurai Circle. It is suggested that the same may also be considered for the redeployment as Assistant Executive Engineer/Civil for Kallakuruchi EDC.
