There was a long dispute on the eligibility
criterion for grant of additional charge allowance to
the engineers who were asked to hold full additional
charge of certain posts which have separate
jurisdiction and are independent in Thermal Power
Stations. The Board has clarified to grant additional
charge allowance to such officials holding additional
charges of the posts of Assistant Engineers/Assistant
Executive Engineers/ Senior chemists working in the
Thermal Power Stations in certain fields vide the
Memo cited.

2. Gas Turbine Power Stations are similar in
nature to Thermal Power Stations in almost all
aspects. Assistant Engineers/ Assistant Executive
Engineers serving in Gas Turbine Power Stations are

to be treated on par with the AEs/AEEs serving in Thermal Power Stations. But these engineers are not covered by the clarification issued under the Memo cited. It is therefore necessary to include them for similar consideration for grant of additional charge allowance.

This Association, therefore, requests that the respected CMD may be pleased to pass appropriate orders extending similar consideration for grant of additional charge allowance as granted in the Memo cited to the Assistant Engineers/ Assistant Executive Engineers of Gas Turbine Power Stations, who are asked to hold full additional charge of independent posts with distinct jurisdiction.
